

2021 AOV/AWW AMOUNTS

The Director of the Social & Health Insurances St. Maarten (SZV) would like to inform the general public of the 2021 AOV/AWW amounts and the maximum wage limits. These amounts went into effect as of July 1st, 2020.

In July 2020, the National Ordinance increase of AOV benefit and increase of retirement age to 65 (Landsverordening verhoging AOV-pensioen en pensioenleeftijd tot 65 jaar) was passed by Parliament and published (AB 2020, no. 44).

Article I of this ordinance stipulates an increase of the maximum AOV benefit as of July 1st, 2020 from NAf 1.116,- to NAf 1.240,- per month.

Article VI of this ordinance stipulates that the regular indexation of the AOV and AWW amounts will be omitted for January 1st, 2021.

Kindly take notice of the two tables below for the amounts of AOV (table 1.) and for AWW (table 2.) for 2021.
